25) Old & New Business

Homelessness Social Services Request

Councilor Smitherman asked for an update from the organizations that are in the budget, how the City can reach out to them for any instances occurring in the districts.

AIDS Alabama - provides a range of essential services to support the community in the battle against HIV. The comprehensive offerings include social services, transportation assistance, support for substance misuse, mental healthcare, etc. they also offer, free, confidential and anonymous rapid HIV testing, Hepatitis C testing, STI infections, and treatment at no cost. They are administering over \$4 million annually I affordable hous8ign initiatives. Their primary goal is to enhance access to affordable housing and transition clients from emergency shelters to stable and independent homes.

Family Connection – a non-profit organization that serves youth through safety, shelter and counseling services. They operate their project Hope facility that serves run-away, homeless, street, and at-risk youth ages 12 to 21. They provide case management, life skills training, transportation, access to medical supplies, hygiene products, clothing etc.

Pathways – a shelter for women and children experiencing homeless. The offer three programs for women and children experiencing street homelessness. They have the safe haven program for women with severe mental illness experiencing homelessness. They are a United Way agency, and receives City of Birmingham and Jefferson County funding.

First Light Shelter – provides emergency shelter to homeless women and woman with children. They also assist with finding permanent supportive housing. They provide weekly group and individual counseling.

Community on the Rise – opened in 2020. They focus on providing the homeless with housing, employment, education and healing around trauma. One of the primary outreach services they provide is twice weekly ID clinics. Their comprehensive housing program serves women experiencing homelessness.

The Firehouse Shelter – a lifeline for Birmingham's chronically homeless men since 1983. They provide essential services to over 5,000 of the most venerable individuals through a broad and comprehensive range of programs. The day shelter operates 5 days a week and is open to anyone in the community. Three nutritious meals are provided daily.

The Jimmy Hale Mission – the mission has been operating in the City of Birmingham for 80 years. It is a comprehensive service provider that provides all services free of charge to all in need. They operate three facilities. They also operating Jesse's Place, a center for woman and children.

Bridge Ministries – provides homeliness prevention rather than services directly to the homeless. They do not have shelter, but occasionally provide vouchers for motels.

One Roof – coordinate all the homeliness services. They are the conduit through which all the providers play well together. They maintain the data that helps the City of Birmingham, Jefferson County, and surrounding municipalities make data-driven decisions. They help people find the services they need. Their outreach service covers all of the Jefferson, Shelby and St. Clair counties.
