The Mayor is authorized to solicit generically donations and participation of citizens and local vendors, through such means as billboards, radio ads or other indirect means. The City is authorized to receive and distribute donations of toys and other items to provide for the care and emotional support of poor and needy children residing within the City, during the 2024 holiday season. Expenditure of City funds for the Magic City Toy drive shall be in accordance with Birmingham General City Code §3-1-7 and shall not exceed \$10,000.00. | <p>14.</p> <p>A Resolution to authorize the Mayor to execute an Amendment No. 1 to the three-year Vendor Agreement, entered into on January 29, 2024, pursuant to §11-40-1 and §11-43-55 of the Code of Alabama, 1975, with LiveView Technologies, Inc. ("LVT"), for LVT to provide the City Police Department (BPD) with two D3 Live Units, for a total of Two Hundred Seven Thousand Four Hundred Eighty and 00/100 Dollars (\$207,480.24). This Amendment No. 1 adds three additional D3 Live Units to the City, which includes, but is not limited to: (1) two subscriptions - Smart Generator; (2) two Mobile Mount- Solar-Gen; (3) Setup; and (4) Shipping; for an additional cost of Two Hundred Fifty Thousand Seven Hundred Five and 29/100 Dollars (\$250,705.29). The Mayor is further authorized to spend up to an additional \$10,000.00/year to cover relocation and data expenses. The total amount to be expended shall not exceed Four Hundred Eighty-eight Thousand One Hundred Eighty-five and 53/00 Dollars (\$488,185.53).
