Electric Transportation Strategy

Alabama Power's EV Program assists customers with incentives around adoption, identifying and executing future growth opportunities in the electric transportation space, promoting Alabama Power's leadership in electric transportation, and helping with policies that drive transportation electrification.

Alabama has approximately 20,000 EV's in operation.

The Alabama Electric Vehicle usage has experienced a significant increase. During the months of January through May, more than 1,000 EV's have come onto the market.

Residential Electric Vehicle Customer Solution

EV night charging (whole house power discount) - residential rate rider discount for off peak charging for the hours of 9:00 p.m. until 5:00 a.m.

There is a level two charger rebate available in the amount of \$500.00.

The EV Gridwise Program has been launched; optimizing the at-home charging and supports grid resiliency and does offer opportunities with gift cards incentives.

Commercial & Industrial Solutions

There are make-ready rebates for commercial or industrial customers looking to put in chargers for workplace or public charging opportunities.

Rebates are provided at different power ratings.
