The request is a shared funding agreement between the City of Homewood and the City of Birmingham to repair a drainage channel beside Green Springs Highway right before Valley Avenue. The channel has eroded and washed out. The right of way is split between the two cities, and both have agreed to split the cost of repair. Homewood has bid and will manage the project.

Failure of the BJCTA to provide the final strategic plan document by the deadline will not be considered grounds for the City to delay service payments described in the agreement. **Action Taken:**
