III. Rebuild Alabama Act (RAA) Annual Grant Program Application – Repaving Lakeshore Parkway from West Oxmoor to Industrial Drive/Tom Martin Drive

The Rebuild Alabama Grant is the smaller of two State-funded grant programs from the Rebuild Alabama Act that can be used on local roads. BDOT is requesting \$350K from the Rebuild Alabama Grant Fund Account and \$100K in local match. The local match will come from the gas tax account. The portion of Lakeshore that is being repayed was chosen because of regional significance, and the conditions are deteriorating.

The request is for approval to apply and allocate \$100k from the gas tax refund account as the match.

IV. BJCTA Update – Route Changes

Presented by: Britnee Thomas, Planning Manager, BJCTA

Beginning January 2025, BJCTA will implement the following route modification will be implemented Microtransit Introduction/Zone Expansion

The mircrotransit will allow customers to have more access to grocery stores, healthcare, education and entertainment facilities, particular in the southwest area of Birmingham, and will consist of 11.2 square miles.

There will be increased connectivity for the following locations:

- CrossPlex Transit Center
- Elmwood BRT Station
- Routes 1 South Bessemer, 3 Jefferson, 45 Bessemer, 48 South Powderly, Birmingham Xpress and Birmingham on Demand.

Route 20 will convert into full mircrotransit.

- The bus will be removed from the route, which will take away approximately 51 bus tops from the system.
- The fixed route will no longer run from 7a 5p.
- The Microtransit hours are 5a 9:30p.
- There will be increased connectivity to Routes 17 Eastwood, 25 Center Point Birmingham Xpress, and Birmingham on Demand

Community meetings are scheduled for December 18, 2024, 5p, Woodlawn Transit Center, and January 14, 2025, 5p, BJCTA Intermodal Facility to update citizens on the anticipated changes.
